RESOLUTION NO. SP **2341**S-2003

A RESOLUTION AUTHORIZING THE HONORABLE HERBERT M. BAUTISTA, CITY VICE MAYOR, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY OF THE REPUTABLE AND/OR ACCREDITED CONTRACTORS TO UNDERTAKE THE ASPHALTING OF VARIOUS ROADS AND STREETS, REPAINTING OF VARIOUS GOVERNMENT STRUCTURES AND BUILDINGS, INSTALLATION OF STREET LIGHTING FACILITIES AND OTHER LIGHTING FACILITIES, CONSTRUCTION OF WAITING SHEDS, PLAYGROUND EQUIPMENT, CONSTRUCTION OF MULTI-PURPOSE BUILDINGS, CONSTRUCTION OF PARKS AND PROMENADE, ALL IN DISTRICT IV, QUEZON CITY, TO BE TAKEN FROM THE 2004 ANNUAL BUDGET UNDER ITEM CAPITAL OUTLAY PUBLIC INFRASTRUCTURE FUND OF THE CITY COUNCIL.

WHEREAS, the City envisions to establish a quality community that is responsive and effective to the needs of its constituency;

WHEREAS, infrastructure projects are indicative of progress and development and as the City attained the stature of being the richest and most solvent City in the country, it is just fitting and proper that the challenges that go with this transformation be met accordingly through meaningful and significant infrastructure projects;

WHEREAS, ocular inspection and appropriate program of works were prepared by the Office of the City Engineer for the purpose;

WHEREAS, these projects are necessary in order to avoid danger to life, limbs and properties as many of said projects require immediate rehabilitation/improvement in order to further arrest deterioration thereby avoiding perils and dangers to the availing public;

NOW, THEREFORE,


