RESOLUTION NO. SP **2344**S-2003

A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON OCTOBER 1, 2003 AT KAUNLARAN STREET, BARANGAY BATASAN HILLS, QUEZON CITY, COMPRISING OF THIRTY-FOUR (34) FAMILY HOMEOWNERS/SHARERS AT TWO THOUSAND PESOS (P2,000.00) EACH, IN THE TOTAL AMOUNT OF SIXTY-EIGHT THOUSAND PESOS (P68,000.00), TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

Introduced by Councilors RAMON P. MEDALLA, VOLTAIRE GODOFREDO L. LIBAN III, ERIC Z. MEDINA, AIKO MELENDEZ, ALLAN BUTCH T. FRANCISCO, and MARY ANN L. SUSANO.

WHEREAS, a fire occurred on October 1, 2003 at Kaunlaran St., Brgy. Batasan Hills, this city, rendering homeless thirty four (34) family homeowners/renters/sharers,


WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the sangguniang panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events".

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, Quezon City Mayor Feliciano R. Belmonte, Jr., to grant financial assistance to the victims of the fire that occurred on October 1, 2003 at Kaunlaran St., Brgy. Batasan Hills, Quezon City, comprising of thirty-four (34) family homeowners/renters/sharers at turns in the total amount of Sixty Eight Thousand Pesos (P68,000.00) to be taken from any available funds of the City Treasury.
