RESOLUTION NO. SP-2346, S-2003

A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A DISABLE RAMP AT THE BARANGAY HALL OF BARANGAY BLUE RIDGE B, DISTRICT III, QUEZON CITY.

WHEREAS, it would be immediately and easily materialize if our city government will assist Barangay Blue Ridge B in financing said project;

WHEREAS, Section 458 (a) (5) (v) of Republic Act 7160, otherwise known as the Local Government Code of 1991, empowers the City Council to regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same; establish bus and vehicle stops and terminals or regulate the use of the same by privately-owned vehicles which serve the public; xxx.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor Feliciano R. Belmonte, Jr. to allocate funds for the construction of a disable ramp at the Barangay Hall of Barangay Blue Ridge B, District III, Quezon City.
