RESOLUTION NO. SP-**2349**, S-2003¹¹

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ACQUIRE THE ONE HUNDRED FORTY-EIGHT (148) SQUARE METER LOT LOCATED AT HILLCREST STREET, BARANGAY IMMACULATE CONCEPTION, CUBAO, THIS CITY, WHICH IS BEING USED AS A RIGHT-OF-WAY BY HILLCREST NEIGHBORHOOD ASSOCIATION.

WHEREAS, the owner of the One Hundred Forty-Eight (148) square meter lot located in Hillcrest Street, Barangay Immaculate Conception, has made an offer to sell the property to the government;

WHEREAS, for one reason or another, no positive outcome has resulted from the offer and the owner has threatened to fence off the property if no settlement is reached by December 5, 2003;

WHEREAS, a fence around the property will adversely affect about One Hundred Fifty (150) homeowners of the Hillcrest Neighborhood Association.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., to acquire, either by negotiation or expropriation, the One Hundred Forty-Eight (148) square meter lot located at Hillcrest Street, Bgy. Immaculate Conception, Cubao, Quezon City, which is being used as a right-of way by the Hillcrest Neighborhood Association.
