RESOLUTION NO. SP- **2350** S-2003

A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON NOVEMBER 2, 2003, AT SAINT PETER AND SAINT JOSEPH STREETS, BARANGAY NEW ERA, QUEZON CITY, COMPRISING OF THIRTY (30) FAMILY HOMEOWNERS AT TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT OF SIXTY THOUSAND PESOS (P60,000.00), TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2004 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, a fire occurred on November 2, 2003 at Saint Peter and Saint Joseph Streets, Barangay New Era, this City, rendering thirty (30) families homeless;

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events".


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, Quezon City Mayor Feliciano R. Belmonte, Jr., to grant financial assistance to the victims of the fire that occurred on November 2, 2003 at Saint Peter and Saint Joseph Streets, Brgy. New Era, Quezon City, comprising of Thirty (30) family homeowners at Two Thousand Pesos (P2,000.00) each in the total amount of Sixty Thousand Pesos (P60,000.00), to be charged against the appropriation for Grants, Subsidies and Contribution in the 2004 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.


