A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE BEREAVED FAMILY OF THE LATE ELIZEA DIMAANO, FORMER PUNONG BARANGAY OF BARANGAY BALUMBATO, QUEZON CITY, WHO DIED ON OCTOBER 11, 2003, CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2004 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.
