RESOLUTION NO. SP-**2353**S-2003

A RESOLUTION URGING THE CITY COUNCIL TO APPROVE THE INCREASE IN THE ROUTE MEASURE CAPACITY (RMC) OF SAN ROQUE IN THE 3rd DISTRICT OF QUEZON CITY FROM THE ORIGINAL NUMBER OF ONE HUNDRED (100) UNITS TO ONE HUNDRED THIRTY-SEVEN (137), PROVIDING FOR AN ADDITIONAL THIRTY-SEVEN (37) UNITS TO BE REGISTERED.

WHEREAS, San Roque Tricycle Operators and Drivers Association is a duly registered with the Securities and Exchange Commission, the Quezon City Tricycle Franchising Board and the Tricycle Regulatory Unit, the LTO and LTFRB;

WHEREAS, the Route Measure Capacity (RMC) of the San Roque Tricycle Operators and Drivers Association was determined based on the data in the early 1990's and definitely is no longer applicable to the present situation;

WHEREAS, the increase in the number of population and the riding public leads to an increase in the number of trips and higher demands in public transportation necessitating for an increase in the said number of RMC;

WHEREAS, the increase in the number of RMC will allow the legalization of the number of colorums plying the route of the said TODA;
