RESOLUTION NO. SP-2355, S-2003

A RESOLUTION APPROVING THE RECOMMENDATION OF THE NON-GOVERNMENTAL ORGANIZATIONS (NGO 's) AND PEOPLE'S ORGANIZATIONS (POs) ACCREDITATION COMMITTEE FOR THE ACCREDITATION 0F FIFTY-ONE (51)CIVIL SOCIETY ORGANIZATIONS (CSOs), NON-GOVERNMENTAL ORGANIZATIONS (NGO's), AND PEOPLE'S ORGANIZATIONS (POs), PURSUANT TO THE PROVISIONS OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS LOCAL GOVERNMENT CODE 0F IMPLEMENTING RULES AND REGULATIONS, IN RELATION TO DILG MEMORANDUM CIRCULAR NO. 2001-89.

WHEREAS, the Local Government Code of 1991 and its implementing rules and regulations require that the City Council shall call all community-based people and non-government organizations, civil society and private sector organizations, including business and professional groups to apply for accreditation with the City Council for possible membership in the local special bodies;

WHEREAS, Ordinance No.SP-23, S-92, an Ordinance creating the NGO and PO Accreditation Committee hereinafter referred to as Committee, for brevity, headed by the Chairman of the Committee on Public Affairs, Information and People's Participation with the Community Relations Officer, the Chairman of the Committee on Barangay Affairs, City Council Secretary and representative from the Office of the Vice Mayor, as members, was enacted with the primary task of processing applications for accreditation;

WHEREAS, following the instruction contained in DILG Memorandum Circular No. 2001-89, dated July 24, 2001, the City Council, thru His Honor, Vice Mayor Herbert M. Bautista, sent invitations to all NGO's, POs and CSOs to apply for accreditation;

WHEREAS, the Committee on its 5th Committee report dated November 14, 2003 recommended the grant and approval of Fifty-One (51) applicants for accreditation and henceforth be accredited by the City Council pursuant to Article 64 (b) of RA No. 7160's Implementing Rules and Regulations in relation to DILG Memorandum Circular No. 2001-89, copy of the report is here to attached and form an integral part of this Resolution.
