RESOLUTION NO. SP-**2356**, S-2003

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH A REPUTABLE CONTRACTOR FOR THE CONSTRUCTION OF VARIOUS PROJECTS LOCATED IN DISTRICT IV AND III, QUEZON CITY, IN AN AMOUNT NOT EXCEEDING FOUR MILLION EIGHT HUNDRED SIXTY-FOUR THOUSAND EIGHT PESOS AND SEVENTY CENTAVOS (P4,864,008.70) TO BE FUNDED AGAINST THE LUMP SUM APPROPRIATION OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, the proposed various projects have been identified by the Councilors as among the priority development projects of the City government to wit:



WHEREAS, pursuant to Section (b)(1)(vi) of RA 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Feliciano R. Belmonte, Jr., to enter into a negotiated contract with the registered and pre-qualified contractor of the City for the construction of Barangay outposts, fabrication and installation of waste management receptacles and construction of basketball court in U.P. Campus, Quezon City, and in the different areas in Districts III and IV of Quezon City in an amount not exceeding its cost estimate to be charged against the Lump Sum Appropriation Fund (Capital Outlay Infrastructure Fund) of the Office of the City Mayor.
