RESOLUTION NO. SP-**2360**, S-2004

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO MORE THAN TWO HUNDRED FIFTY (250) FAMILIES AFFECTED BY THE FIRE ON DECEMBER 6, 2003 THAT RAZED RESIDENTIAL AREA IN BARANGAY LIBIS AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY OTHER AVAILABLE FUND IN THE CITY TREASURY.

WHEREAS, local government units are empowered under Section 458 (a), (f), (iv) of RA 7160 "to adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events;"

WHEREAS, a fire razed houses at the residential of Barangay Libis on December 6, 2003.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to extend financial assistance to more than Two Hundred Fifty (250) family-victims of the fire on December 6, 2003 that razed a residential area in Barangay Libis, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer which shall be taken from the Calamity or Emergency Fund of the City government or from any other available fund in the City Treasury.






