RESOLUTION NO. SP-**2362**S-2004

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE JR., CITY MAYOR, QUEZON CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY OF THE REPUTABLE AND ACCREDITED CONTRACTORS TO UNDERTAKE THE CONSTRUCTION OF A MULTI-PURPOSE COVERED COURT AT DOÑA JOSEFA EDRALIN MARCOS ELEMENTARY SCHOOL IN BARANGAY SAN ROQUE, QUEZON CITY.

WHEREAS, the administration of the Doña Josefa Edralin Marcos Elementary School in Barangay San Roque, Quezon City, headed by its Principal, Ms. Benifreda M. Sales, has requested for the construction of a multi-purpose hall for the school;


WHEREAS, the Office of the City Engineer has already conducted an ocular inspection of the project site located at 18th Avenue, Barangay San Roque, Quezon City;

WHEREAS, the construction of this multi-purpose hall would greatly benefit the students enrolled at the Doña Josefa Edralin Marcos Elementary School;

WHEREAS, the Office of the City Engineer has prepared and submitted a Program of Work and Detailed Estimate for the proposed construction of a multi-purpose covered court at the Doña Jose Edralin Marcos Elementary School in the amount of Three Million Seven Hundred Forty-Nine Thousand Nine Hundred Sixty-Nine Pesos and Thirty-Eight Centavos (PhP3,749,969.38).


