RESOLUTION NO. SP-**2368**, S-2004

A RESOLUTION URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO CONVENE THE "MARKET COMMITTEE ON AWARDS", SO AS TO PREPARE AN IMPLEMENTING RULES AND REGULATIONS NECESSARY THEREFOR.

WHEREAS, the City government is mandated to regulate the operation of all establishments within its jurisdiction, which includes public markets;

WHEREAS, Chapter IV - Section 1 of Ordinance No. SP-994, S-2000, otherwise known as the Quezon City Market Code, provides for the creation of the Market Committee on Awards, stipulated therein the composition and functions of the concerned agencies comprising the same;

WHEREAS, the said committee is tasked to conduct the drawing of lots and opening of bids for the adjudication of vacant or newly constructed stall or booths in the City's public markets;

WHEREAS, however, the said Council has not yet convened, thus, it impedes full implementation of the said ordinance;

WHEREAS, moreover, the said provision makes it imperative on the said committee to regularly convene and to dispose the functions necessary in resolving problems concerning the occupancy of stalls, booths, spaces in the public markets;



WHEREAS, the same Ordinance necessitates an effective inter-agency involvement in addressing the various concerns of the public markets relative to the aforesaid objective.


NOW, THEREFORE,


