RESOLUTION NO. SP-**2370**, S-2004

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY ACCREDITED AND REPUTABLE CONSTRUCTION FIRM FOR THE CONCRETING OF TWO (2) TENNIS COURTS PAVEMENT LOCATED AT ROAD 9, AND BLISS CONDOMINIUM, BARANGAY BAGONG PAG-ASA WITH THE SAME TOTAL PROJECT ESTIMATED COST IN THE AMOUNT OF TWO HUNDRED SEVENTY THREE THOUSAND EIGHT HUNDRED EIGHTY-FIVE PESOS AND FIFTEEN CENTAVOS (P273,885.15) TO BE CHARGED TO THE GENERAL FUND OF THE CITY COUNCIL UNDER CAPITAL OUTLAY.

WHEREAS, local government units are empowered to exercise powers and discharge functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provision of basic services and facilities;

WHEREAS, such basic services and facilities include, but not limited to maintenance of barangay roads x x x, infrastructure facilities such as multi-purpose hall, multi-purpose pavement, plaza, sports center and other similar facilities;

WHEREAS, two (2) tennis courts pavement located at Road 9 (near the Barangay Hall), and BLISS Condominium, at Barangay Bagong Pag-asa needs upgrading and/or concreting to cope up with present standard;

WHEREAS, upon request, the Office of the City Engineer had conducted already an ocular inspection, and submitted a program of work and cost estimate for the concreting of two (2) tennis courts pavement located at City Road 9, and BLISS Condominium in Barangay Bagong Pag-asa, with the same total project cost estimate in the amount of Two Hundred Seventy-Three Thousand Eight Hundred Eighty-Five Pesos and Fifteen Centavos (P273,885.15);



NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor Feliciano R. Belmonte, Jr., to enter into a negotiated contract with any accredited and reputable construction firm for the concreting of two (2) tennis courts pavement located at Road 9 and BLISS Condominium, Barangay Bagong Pag-asa with the same total project estimated cost in the amount of Two Hundred Seventy-Three Thousand Eight Hundred Eighty-Five Pesos and Fifteen Centavos (P273,885.15) to be charged to the General Fund of the City Council under Capital Outlay.
