NEMIA H. VILLAFLORES.

WHEREAS, the Parent's Alternative, Inc., a duly registered non-governmental organization, has presented a project proposal for the benefit of the distressed, disadvantaged, and the indigent constituents in Quezon City to the representative of the Bayan Muna Party-List;

WHEREAS, Hon. Siegfred Deduro, Bayan Muna Party-List Representative, has allocated One Million Seven Hundred Thousand Pesos (Php 1,700,000.00) out of his Priority Development Assistance Fund (PDAF) for the implementation of the said project;


WHEREAS, the above-mentioned amount has been issued to the Quezon City government pursuant to the directive of Her Excellency, President Gloria Macapagal-Arroyo, the Quezon City government being the conduit in the implementation of priority development programs and projects of legislators.
