SIEGFRED DEDURO AND THE CHILDREN'S REHABILITATION CENTER, INC. (CRC) REPRESENTED BY MS. MARIA ISABEL B. LANADA.

WHEREAS, the Children's Rehabilitation Center, Inc., a duly registered non-governmental organization, has presented a project proposal for the benefit of the distressed, disadvantaged, and indigent constituents in Quezon City to the representative of the Bayan Muna Party-List;

WHEREAS, Honorable Siegfred Deduro, Bayan Muna Party-List Representative, has allocated One Million Seven Hundred Thousand Pesos (Php 1,700,000.00) out of his Priority Development Assistance Fund (PDAF) for the implementation of the said project;


WHEREAS, the above-mentioned amount has been issued to the Quezon City government pursuant to the directive of Her Excellency, President Gloria Macapagal-Arroyo, the Quezon City government being the conduit in the implementation of priority development programs and projects of legislators.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Feliciano R. Belmonte, Jr., to enter into a Memorandum of Agreement for the Psycho-Social for Sexually Abused and Battered Children Program with Bayan Muna Party-List Representative, Honorable Siegfred Deduro and the Children's Rehabilitation Center, Inc., represented by Ms. Maria Isabel B. Lanada.

RESOLVED, FURTHER, that a copy of the said agreement signed by the parties concerned shall form part of this Resolution.
