A RESOLUTION RATIFYING THE DEED OF DONATION AND ACCEPTANCE EXECUTED BY AND BETWEEN THE DONOR, HI-MARKETING CORPORATION, REPRESENTED BY ITS ATTORNEY-IN-FACT, ATTY. IRENEO D. 
WHEREAS, the said Corporation has donated in favor of the Quezon City government the above described parcel of land to be used as road, alley, and footpath for public passage.
