RESOLUTION NO. SP- 2378, S-2004

A RESOLUTION AUTHORIZING THE SANGGUNIANG BARANGAY OF THE VARIOUS BARANGAYS IN THE THIRD DISTRICT OF QUEZON CITY, TO ENTER INTO CONTRACT FOR THE ACQUISITION AND INSTALLATION OF FIRE HYDRANTS TO BE PLACED IN AREAS NOT EASILY ACCESSIBLE TO FIRE TRUCKS IN THE EVENT OF FIRE IN THEIR RESPECTIVE LOCALITIES PAYABLE FROM THEIR RESPECTIVE INTERNAL REVENUE ALLOTMENT (IRA).

Introduced by Councilors JULIAN M.L. COSETENG, VICTOR V. FERRER, JR., VOLTAIRE GODOFREDO L. LIBAN III, ERIC Z. MEDINA, MARY ANN L. SUSANO, ANTONIO E. INTON, JR. and RESTITUTO B. MALAÑGEN.

WHEREAS, the Sangguniang Barangay of the various barangays in the Third District of Quezon City have provided in their Barangay Annual Budget for Fiscal Year 2003 an allocation for the acquisition and installation of fire hydrants in the densely populated areas in their respective barangays;

WHEREAS, the need for the fire hydrants in the densely populated areas are deemed indubitably urgent and necessary,

WHEREAS, majority of these areas are inaccessible by fire trucks in the event of fire because of their narrow access roads, if not without any established road at all;

WHEREAS, destructive and calamitous fire can strike in any place at no given time;

WHEREAS, the victims are almost always left with no belongings at all. Consequently, they helplessly beg for alms from the government;


WHEREAS, the Manila Water Company will be tapped as the source of the water wherein the barangay will pay the amount corresponding to the total usage from their respective funds;

WHEREAS, the Sangguniang Barangay will formulate and adopt implementing rules and regulations therefor, which will include the qualifications and appointment of a key-keeper who will be responsible in keeping the keys to these fire hydrants and ensure their availability twenty-four (24) hours a day.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Sangguniang Barangay of the various barangays in the third district of Quezon City, to enter into contract for the acquisition and installation of fire hydrants to be placed in areas not easily accessible to fire trucks in the event of fire in their respective localities payable from their respective Internal Revenue Allotment (IRA).


