RESOLUTION NO. SP- 2379, S-2004

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ALONG DAPITAN STREET BETWEEN IBA TO MARIVELES STREETS, BARANGAY STA. TERESITA, DISTRICT I, QUEZON CITY, LAST SEPTEMBER 17, 2003, THE AMOUNT TO BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

WHEREAS, on September 17, 2003, a fire occurred and blazed the structures along Dapitan St. from Iba to Mariveles Streets, Barangay Sta. Teresita, District I, Quezon City, leaving number of families homeless;

WHEREAS, the City government can express its sympathy and concern by way of providing financial assistance to the victims of the fire.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the victims of the fire that occurred along Dapitan Street from Iba to Mariveles Streets, Brgy. Sta. Teresita, District I, Quezon City, last September 17, 2003, the amount to be taken from the Calamity or Emergency Fund of the City government or from any available fund of the City, as follows:


House owners	-----	P2,000.00 each
House renters/sharers	-----	P1,000.00 each

RESOLVED, FURTHER, that the Social Services Development Department (SSDD) shall validate/authenticate the list of the fire victims categorized into house owners or house renters/sharers and to submit the same to the Office of the City Mayor making representation for the early release of the financial assistance to the qualified recipients.


