A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY THE CITY MAYOR HONORABLE FELICIANO R. BELMONTE, JR., AND IPM ENVIRONMENTAL SERVICES, INC., REPRESENTED BY ITS PRESIDENT MS. ISABELITA PAREDES-MERCADO.

WHEREAS, while extra care is being done in operating the site to ensure that it can continuously be utilized to absorb the City's almost 1,500 tons of waste generated daily, the limited space and the danger that it's continued use has posed, aggravated by the heavy rains during the past weeks, have all the more put a heavy pressure on the City to improve the existing conditions of the Payatas Dumpsite;


WHEREAS, in view of the urgency of the situation and sensitive to the risks to the life and property, the City government has filed an application to the DENR to convert the Payatas Dumpsite into a Controlled Dump Facility;

WHEREAS, in compliance with the requirements of R.A. 9003 otherwise known as the Ecological Solid Waste Management Act of 2000 and in order to ensure that the city will have a safe and environmentally acceptable waste disposal facility for the next two and a half years, the services of a contractor-operator for the conversion of the Payatas Dumpsite into a controlled facility was engaged by virtue of Resolution No. SP-2239, S-2003.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Memorandum of Agreement entered by and between the Quezon City government, represented by the City Mayor, Honorable Feliciano R. Belmonte, Jr., and IPM Environmental Services, Inc., represented by its President Ms. Isabelita Paredes-Mercado.
