RESOLUTION NO. SP-**2384**, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE CONTRACTOR FOR THE REHABILITATION AND IMPROVEMENT OF DRAINAGE ALONG STA. IGNACIANA STREET CORNER 17<sup>TH</sup> STREET, BARANGAY KALUSUGAN, QUEZON CITY, AND APPROPRIATING THE AMOUNT OF THREE HUNDRED SEVENTY-FOUR THOUSAND FOUR HUNDRED SIX PESOS AND SEVENTY-SIX CENTAVOS (P374,406.76) FOR THE PURPOSE.

Introduced by Councilors ANTONIO E. INTON, JR., JESUS MANUEL C. SUNTAY, ALMA F. MONTILLA, JANET M. MALAYA, RICARDO R. DEL ROSARIO, RESITUTO B. MALANGEN, VINCENT P. CRISOLOGO, ROMMEL R. ABESAMIS, VOLTAIRE GOLDOFREDO L. LIBAN III, ERIC Z. MEDINA and JORGE L. BANAL.

WHEREAS, flooding in these areas are now perennial problems of Barangay Kalusugan residents as well as its adjoining barangays, particularly the incoming onslaught of the rainy season;

WHEREAS, the Barangay Council of Barangay Kalusugan is seeking for assistance for the rehabilitation and improvement of drainage along Sta. Ignaciana Street corner 17<sup>th</sup> Street;


WHEREAS, as per estimate conducted and prepared by Ms. Eden C. Briones, Project Inspector of the Office of the City Engineer, the said project will cost Three Hundred Seventy-Four Thousand Four Hundred Six Pesos and Seventy-Six Centavos (P374,406.76), a copy of the project program is hereto attached;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of RA 7160, otherwise known as the "Local Government Code of 1991", the city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to enter into a negotiated contract with any reputable contractors for the rehabilitation and improvement of drainage along Sta. Ignaciana Street corner 17<sup>th</sup> Street, Barangay Kalusugan, Quezon City, and appropriating the amount of Three Hundred Seventy-Four Thousand Four Hundred Six and Seventy-Six Centavos (P374,406.76) for the purpose.
