RESOLUTION NO. SP-2385, S-2004

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY ACCREDITED AND REPUTABLE CONSTRUCTION FIRM FOR THE ASPHALT OVERLAYING OF ILOCOS NORTE STREET LOCATED AT BARANGAY RAMON MAGSAYSAY, DISTRICT I, QUEZON CITY, IN THE AMOUNT OF NINE HUNDRED TWENTY THOUSAND SIX HUNDRED FIFTY-ONE PESOS AND NINE CENTAVOS (P 920,651.09) OR SO MUCH THEREOF, TO BE CHARGED TO THE GENERAL FUND OF THE CITY COUNCIL UNDER CAPITAL OUTLAY.

WHEREAS, one of the streets in District I, this City, that needs improvement is Ilocos Norte Street, located at Barangay Ramon Magsaysay,


WHEREAS, upon request, the Office of the City Engineer had conducted already an ocular inspection and submitted a Program of Work and Cost Estimate in the amount of Nine Hundred Twenty Thousand Six Hundred Fifty-One Pesos and Nine Centavos (P 920,651.09) for the asphalt overlaying of the above-mentioned street,

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor is empowered to represent the city in all business transactions and sign in its behalf all bonds, contracts, and obligations; and such other documents upon authority of the sangguniang panglungsod or pursuant to law or ordinance.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor Feliciano R. Belmonte, Jr., to enter into a negotiated contract with any accredited and reputable construction firm for the asphalt overlaying of Ilocos Norte Street located at Barangay Ramon Magsaysay, District I, Quezon City, in the amount of Nine Hundred Twenty Thousand Six Hundred Fifty-One Pesos and Nine Centavos (P 920,651.09) or so much thereof, to be charged to the General Fund of the City Council under Capital Outlay.
