RESOLUTION NO. SP- **2387**, S-2004

A RESOLUTION AUTHORIZING THE HONORABLE HERBERT M. BAUTISTA, CITY VICE MAYOR, QUEZON CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY OF THE REPUTABLE AND ACCREDITED CONTRACTORS TO UNDERTAKE VARIOUS INFRASTRUCTURE PROJECTS IN DIFFERENT BARANGAYS IN DISTRICT IV, QUEZON CITY.

WHEREAS, some of the barangay officials in District IV, Quezon City, requested to undertake infrastructure projects in their barangays;

WHEREAS, the Office of the City Engineer have conducted an ocular inspection on the site of the proposed projects;

WHEREAS, the Office of the City Engineer have prepared and submitted a Program of Work and Detailed Estimate for the proposed projects located in the following barangays:

1. Proposed concreting of Planas Site II, Barangay Kaunlaran;
2. Proposed construction of waiting shed at M.H. Del Pilar Elementary School in Barangay Kamuning;
3. Proposed construction of waiting area at Roxas Elementary School in Barangay Roxas;
4. Proposed improvement of day care center in Barangay Horseshoe;

WHEREAS, it is necessary for the City Council to grant authority to the City Vice Mayor in order for the latter to enter into negotiated contract with any reputable and accredited contractor to implement said projects in different barangays in District IV.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Herbert M. Bautista, City Vice Mayor, Quezon City, to enter into a negotiated contract with any reputable and accredited contractors to implement said projects in different barangays in District IV, Quezon City.
