RESOLUTION NO. SP-**2398**S-2004

A RESOLUTION AMENDING RESOLUTION NO. SP-2373, S-2004, IN ORDER TO AUTHORIZE THE ISSUANCE OF CERTIFICATE OF EXCEPTION TO THE METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM (MWSS) HOUSING PROJECT AT THE LA MESA DAM AREA, BARANGAY GREATER LAGRO, NOVALICHES, QUEZON CITY.

WHEREAS, the Metropolitan Waterworks and Sewerage System (MWSS) is constructing a housing project at the La Mesa Dam property located at Barangay Greater Lagro, Novaliches, Quezon City which, under the Quezon City Zoning Ordinance No. SP-918, S-2000, is classified as Transport and Utilities Zone;

WHEREAS, the MWSS, thru its Administrator, Hon. Orlando C. Hondrade, made representations with the City Mayor, Honorable Feliciano R. Belmonte, Jr., for the issuance of a Certificate of Exception from the provisions of City Ordinance No. SP-918, S-2000, for the said MWSS Housing Project;


WHEREAS, there was an error in the adoption of Resolution No. SP-2373, S-2004, such that what was authorized was the issuance of a Special Use Permit to MWSS for the said housing project instead of a Certificate of Exception for the purpose.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to amend, as it does hereby amend, Resolution No. SP-2373, S-2004, in order to authorize the issuance of a Certificate of Exception to Metropolitan Waterworks and Sewerage System (MWSS) Housing Project at the La Mesa Dam area, Barangay Greater Lagro, Novaliches, Quezon City.

RESOLVED, FURTHER, that the grant of Certificate of Exception shall be subject to all the conditions and limitations prescribed under Quezon City Zoning Ordinance No. SP-918, S-2000, and other pertinent laws, rules and regulations.
