RESOLUTION NO. SP-2399, S-2004

A RESOLUTION GRANTING AN ADDITIONAL SIX (6) ROUTE MEASURED CAPACITY (RMC) FOR THE OPERATION OF MOTORIZED TRICYCLES-FOR-HIRE WITHIN THE ROUTE COVERED BY LOYOLA HEIGHTS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (LHTODA), DISTRICT III, THIS CITY.

Introduced by Councilors RESTITUTO B. MALANGEN, ROMMEL R. ABESAMIS, ERIC Z. MEDINA, RAMON P. MEDALLA, JORGE L. BANAL, JULIAN M.L. COSETENG, JESUS MANUEL C. SUNTAY, JANET M. MALAYA, ANTONIO E. INTON, JR, RICARDO R. DEL ROSARIO and XYRUS L. LANOT.

WHEREAS, despite the legalization program for colorum tricycle units implemented in 1994, 1996, and 1999, new illegally operating tricycle units continue to thrive and proliferate in the City which had deprived legitimate franchise holders in the right income they deserve;

WHEREAS, in attempting to meet such problems, notwithstanding, the number of tricycle established by the Route Measured Capacity (RMC) as the appropriate level of demand, the members of the Quezon City Tricycle Franchising Board, agreed in principle, to legalize all existing unfranchised (colorum) tricycle units in Quezon City by recommending the granting of additional franchises to the Quezon City Council;

WHEREAS, Resolution No. 02, S-2003 of LHTODA, adopted by the Board of Directors on October 2, 2003, seeks for an additional six (6) RMC;

WHEREAS, Resolution No. 126, S-2003, approved by the Barangay Council of Barangay Loyola Heights on November 13, 2003, District III, this City, requests the City Council to grant additional six (6) units to LHTODA in order to cater the needs of the constituents of said barangay and for the safety of its passenger, and that, said application for additional units will serve more people in the community;
