RESOLUTION NO. SP2404 S-2004

A RESOLUTION GRANTING AN ADDITIONAL THIRTY (30) ROUTE THE OPERATION OF MEASURED CAPACITY (RMC) FOR MOTORIZED TRICYCLES-FOR-HIRE WITHIN THE ROUTE COVERED EXTENSION. HIGHWAY AVENUE OUIRINO MINDANAO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (MEQH TODA), DISTRICT II-A, THIS CITY.

Introduced by Councilors RESTITUTO B. MALANGEN, ROMMEL R. ABESAMIS, ERIC Z. MEDINA, RAMON P. MEDALLA, JORGE L. BANAL, JULIAN M.L. COSETENG, JESUS MANUEL C. SUNTAY, JANET M. MALAYA, ANTONIO E. INTON, JR., RICARDO R. DEL ROSARIO, and XYRUS L. LANOT.

WHEREAS, despite the legalization program for colorum tricycle units implemented in 1994, 1996, and 1999, new illegally operating tricycle units continue to thrive and proliferate in the City which had deprived legitimate franchise holders in the right income they deserve; *

WHEREAS, in attempting to meet such problems, notwithstanding, the number of tricycle established by the Route Measured Capacity (RMC) as the appropriate level of demand, the members of the Quezon City Tricycle Franchising Board, agreed in principle, to legalize all existing unfranchised (colorum) tricycle units in Quezon City by recommending the granting of additional franchises to the Quezon City Council;

WHEREAS, Resolution No. 12-03, S-2003, approved by the Barangay Council of Barangay Talipapa on December 17, 2003, District II-A, this City, requests the City Council to grant additional Thirty (30) units to MEQH TODA in order to cater the needs of the constituents of said barangay and for the safety of its passengers, and that, said application units will serve more people in the community;

WHEREAS, as provided for in the said resolution that the proposed route shall be Mindanao Avenue Extension corner Quirino Highway, Biglang-Awa Subdivision, Doña Marciana Subdivision, Duhat Street and Maceda Bridge only and vice versa;

WHEREAS, Resolution No. 2, S-2003 of MEQH TODA, adopted by the Board of Directors on October 7, 2003, seeks for the legalization of their thirty (30) existing colorums;

WHEREAS, the Quezon City government recognizes the importance of an efficient and affordable transport system for public convenience.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, an additional Thirty (30) RMC for the operation of motorized tricycles-for-hire within the route covered by Mindanao Avenue Extension, Quirino Highway Tricycle Operators and Drivers Association (MEQH TODA), District II-A, this City.

RESOLVED, FURTHER, that copy of this Resolution be forwarded to the concerned barangay and offices for their information and appropriate action.
