RESOLUTION NO. SP-**2409**, S-2004

A RESOLUTION URGING THE CITY MAYOR TO ALLOCATE THE AMOUNT OF TWO MILLION EIGHT HUNDRED EIGHTY-SIX THOUSAND EIGHT HUNDRED TWENTY-FOUR PESOS AND SEVEN CENTAVOS (P2,886,824.07) FOR THE RIP-RAPPING OF CULIAT CREEK ALONG SITIO SINAGTALA, BARANGAY BAHAY TORO, DISTRICT I, QUEZON CITY, TO BE CHARGED FROM THE ANNUAL BUDGET UNDER CAPITAL OUTLAY (PUBLIC INFRASTRUCTURE) OF THE CITY PLANNING AND DEVELOPMENT OFFICE OR TO ANY AVAILABLE FUNDS IN THE CITY TREASURY.


NOW, THEREFORE,


