RESOLUTION NO. SP- **2412** , S-2004

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE KAGAWAD CONRADO M. MADRINICO OF BARANGAY PASONG TAMO IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2004 ANNUAL BUDGET OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.


NOW THEREFORE,


