RESOLUTION NO. SP-**2414**, S-2004

A RESOLUTION APPEALING TO HIS HONOR, FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF TWENTY THOUSAND PESOS (P20,000.00) TO THE BEREAVED FAMILY OF THE LATE ERNESTO B. LLAGUNO, BARANGAY TANOD FOR TWENTY (20) YEARS OF BARANGAY LOYOLA HEIGHTS, DISTRICT III, QUEZON CITY, WHO DIED OF HEART ATTACK LAST NOVEMBER 10, 2003.

WHEREAS, the untimely death of Mr. Ernesto B. Llaguno of Barangay Loyola Heights caused immeasurable depression, anguish and anxiety to the members of the family;

WHEREAS, it is a moral obligation of the Members of the City Council and the Local Chief Executive of this City to extend a helping hand by way of granting financial assistance to the bereaved family of the late Ernesto B. Llaguno who died of heart attack last November 10, 2003;

WHEREAS, the loss of a breadwinner and father of the family can really bring undescribable agony and too much grief since the burden of raising children in the coming days, months and years has become too much to bear and the future for the children is becoming bleak due to hardship and financial difficulty that the wife will face afterwards;



BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to appeal, as it does hereby appeal, to his Honor, Feliciano R. Belmonte, Jr., to grant financial assistance in the amount of Twenty Thousand Pesos (P20,000.00) to the bereaved family of the late Ernesto B. Llaguno, Barangay Tanod for twenty (20) years of Barangay Loyola Heights, District III, Quezon City, who died of heart attack last November 10, 2003.

RESOLVED, FURTHER, that copy of this Resolution be forwarded to the Office of the City Mayor, to the bereaved family of the late Ernesto B. Llaguno of Barangay Loyola Heights and to concerned departments of this City, for information and appropriate action.


