RESOLUTION NO. SP- 2415, S-2004

A RESOLUTION SUPPORTING THE PROPOSAL IN CONGRESS TO PROVIDE RISK INSURANCE TO ALL PUBLIC SCHOOL TEACHERS WHO WILL BE ASSIGNED TO UNDERTAKE THE CONDUCT OF THE COMING ELECTION ON MAY 10, 2004.

Introduced by Councilors VOLTAIRE GODOFREDO L. LIBAN III, RAMON P. MEDALLA, ERIC Z. MEDINA, ANTONIO E. INTON, JR., RESTITUTO B. MALANGEN and XYRUS L. LANOT.

Co-Introduced by Councilors Elizabeth A. Delarmente, Rommel R. Abesamis, Jorge L. Banal, Julian M.L. Coseteng, Wencerom Benedict C. Lagumbay and Franz S. Pumaren.

WHEREAS, there is a proposal in Congress to provide Risk Insurance to all public school teachers who will render services in connection with the conduct of the coming May 10, 2004 national and local elections;

WHEREAS, there is always a perceived danger to both lives and timbs of public school teachers who are assigned to assist in the conduct of elections, and the risk of their being charged in court for various crimes in connection with the performance of their respective duties where defeated candidates always bent their anger on said teachers and find them as convenient escape goats for their defeat;

WHEREAS, it is only fit and proper that said public school teachers be provided with Risk Insurance while in the performance of their duties in the conduct of the elections.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to support, as it does hereby support, the proposal in Congress to provide Risk Insurance to all public school teachers who will be assigned to render services during the coming national and local elections on May 10, 2004.
