RESOLUTION NO. SP-2418, S-2004

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO AWARD, BY WAY OF SALE, THE LOT PRESENTLY OCCUPIED BY MRS. AIDA G. FLORES ET. AL., SITUATED AT NO. 94 PAYNA STREET, BARANGAY VETERANS VILLAGE, QUEZON CITY, OWNED BY THE CITY GOVERNMENT AND COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 262147.

WHEREAS, the City government owns a certain government lot at a dead-end portion of Road Lot 42 containing an area of One Hundred Fifty-Two square meters (152 sq.m.) located at Payna Street corner Dangay Street, Barangay Veterans Village, Quezon City;

WHEREAS, the Office of the Barangay Captain of Barangay Veterans Village has interposed no objection on the sale of the said property to the present occupants thereon and issued a certification stating that the said subject property does not obstruct the flow of traffic nor a fire hazard and that they do not have any future barangay nor government projects for the said area;

WHEREAS, the present occupants of the said lot consist of six (6) families namely Mrs. Aida G. Flores, Rocita L. Guinto, Jeremias de la Cruz, Eduarda Ravela, Leonila Prudente, Giolie Ravela, who are residents of the said area for almost forty (40) years;



Flores et.al., situated at No. 94 Payna Street, Barangay Veterans Village, Quezon City, owned by the City government and covered by Transfer Certificate of Title Numbered 262147.
