RESOLUTION NO. SP- 2420, S-2004

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT FOR THE CONCRETING OF PATHWALKS IN VARIOUS AREAS IN DISTRICT I, INSTALLATION OF MOVABLE WASTE SEGREGATION RECEPTACLES, INSTALLATION OF METAL BILLBOARDS FOR ANTI-DRUG PROGRAM OF THE CITY AT SUCH AMOUNT NOT EXCEEDING ITS COST ESTIMATE TO BE CHARGED AGAINST THE LUMP SUM APPROPRIATION FUND (CAPITAL OUTLAY-INFRASTRUCTURE FUND) OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, the concreting of pathwalk, asphalt overlay in various areas, fabrication of movable waste segregation and fabrication of billboards for anti-drug program have been targeted to be undertaken, among others, by the City government to promote and enhance the convenience and welfare of the City residents to wit:

Concreting of Pathwalks in various areas in District I	926,933.61
Fabrication of Movable Waste Segregation	15,999.66
Fabrication of Billboards (Anti-Drug Program)	1,554,021.60

WHEREAS, time is of the essence due to the urgency of the above-proposed projects, the rising cost of labor and materials and to avoid unnecessary delay in attending to the normal conduct of public bidding, it is deemed expedient that the City government enters into a negotiated contract for the early completion of the above-stated projects;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of RA 7160, otherwise known as the Local Government Code of 1991, the city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations; and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor, Feliciano R. Belmonte, Jr., to enter into a negotiated contract with a registered and pre-qualified contractor of the City for the concreting of pathwalks in various areas in District I, installation of movable waste segregation and installation of billboards for anti-drug program of the City at such amount not exceeding its cost estimate to be charged against the Lump Sum Appropriation Fund (Capital Outlay-Infrastructure Fund) of the City Council.
