RESOLUTION NO. SP- 2424 , S-2004

A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON DECEMBER 23, 2003 AT KAMBAL MANGA, STA. MARIA STREET, BARANGAY HOLY SPIRIT, QUEZON CITY, COMPRISING OF SEVENTY-EIGHT (78) FAMILY HOMEOWNERS/RENTERS/SHARERS AT TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT OF ONE HUNDRED FIFTY-SIX THOUSAND PESOS (P156,000.00), TO BE TAKEN AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2004 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, a fire occurred on December 23, 2003 at Kambal Manga, Sta. Maria St., Brgy. Holy Spirit, this City, rendering seventy-eight (78) family homeowners/renters/sharers homeless;


WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991, empowers the sangguniang panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance to victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events".

NOW THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, Quezon City Mayor Feliciano R. Belmonte, Jr., to grant financial assistance to the victims of the fire that occurred on December 23, 2003 at Kambal Manga, Sta. Maria Street, Barangay Holy Spirit, this City, rendering seventy-eight (78) family

homeowners/renters/sharers at Two Thousand Pesos (P2,000.00) each in the total amount of One Hundred Fifty-Six Thousand Pesos (P156,000.00), to be charged against the appropriation for Grants, Subsidies and Contributions in the 2004 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
