RESOLUTION NO. SP **2443** S-2004

A RESOLUTION GRANTING SPECIAL PERMIT TO MUÑOZ BINGO CORPORATION TO OPERATE BINGO GAMES AT THE THIRD LEVEL OF MUÑOZ PLAZA LOCATED AT EDSA CORNER ROOSEVELT AVENUE, QUEZON CITY.

WHEREAS, Muñoz Bingo Corporation, a duly registered entity is applying for a Special Permit from the City Council as a condition precedent for the issuance of Business Permit to operate Bingo Games pursuant to Resolution No. SP-1705, S-2001;

WHEREAS, Muñoz Bingo Corporation has been in operation already since year 2000 and is now applying for a renewal of its business permit;

WHEREAS, Muñoz Bingo Corporation has complied with the various requirements in securing said business permit.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, the Special Permit to operate Bingo Games at the third level of Muñoz Plaza, located at EDSA corner Roosevelt Avenue, Quezon City.

RESOLVED, FURTHER, that the Muñoz Bingo Corporation shall remit to the City Treasurer, in lieu of all taxes, a franchise fee of one half (1/2) of one percent (1%) of the gross revenue of herein grantee which shall be imposed and be made payable yearly to the City Treasurer during the lifetime of this measure.


RESOLVED, FURTHER, that the authority herein granted shall be for a period of two (2) years only, it may be renewed by the City Council.


