RESOLUTION NO. SF **2448**S-2004

A RESOLUTION AUTHORIZING HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY ACCREDITED AND REPUTABLE CONSTRUCTION FIRM FOR THE CONCRETING OF VARIOUS STREETS AND PATHWALKS, CONSTRUCTION AND REPAIR OF VARIOUS GOVERNMENT BUILDINGS AND STRUCTURES, WAITING SHEDS, AND MULTI-PURPOSE BUILDINGS, ALL IN DISTRICT IV, THIS CITY, TO BE TAKEN FROM THE 2004 INFRASTRUCTURE FUND UNDER CAPITAL OUTLAY.

WHEREAS, the local government units are empowered to exercise power, discharge functions, and responsibilities as are necessary, appropriate or incidental to efficient and effective provisions of basic services and facilities;

WHEREAS, there is a need to improve the present location of various government owned infrastructure within its jurisdiction so as to increase the efficiency and effective delivery of public service;

WHEREAS, it is necessary for any local government unit to provide the public a convenient and safe environment, in order to achieve and realize the aforesaid objective;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the city mayor is empowered to represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations; and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance.
