A RESOLUTION URGING THE HONORABLE MAYOR FELICIANO R. BELMONTE, JR., TO IMPLEMENT CITY ORDINANCE NO. SP-163, S-94, ENTITLED: "AN ORDINANCE CREATING THE QUEZON CITY COOPERATIVE DEVELOPMENT CENTER UNDER THE OFFICE OF THE CITY MAYOR TO BE HEADED BY A COOPERATIVE OFFICER AND APPROPRIATING THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FROM THE CITY TREASURY AS INITIAL FUNDS TO COVER ALL EXPENSES OF THE CENTER.

WHEREAS, since its enactment, the said Ordinance has not yet been implemented;

WHEREAS, in order to promote the viability and growth of cooperatives as instruments for social justice and economic development in this City, the creation of the Cooperative Development Center that will formulate and implement an integrated and comprehensive plans and programs on cooperative development is imperative;

WHEREAS, in line with the City government's vision of transforming Quezon City into a quality community, the implementation of Ordinance No. SP-163, S-94 will contribute immensely to its realization.
