RESOLUTION NO. SP- 2460, S-2004

A RESOLUTION PROVIDING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE HONORABLE JUAN R. RABANAL, JR., BARANGAY CAPTAIN, BARANGAY KALUSUGAN, DISTRICT IV, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2004 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, the Honorable Juan R. Rabanal, Jr., Barangay Captain of Barangay Kalusugan, District IV, this City, has joined his Creator last January 6, 2004 at the age of 53;

WHEREAS, he dedicated almost two decades of his life serving his constituents as Barangay Captain from 1997 until his untimely passing;

WHEREAS, his legacy will always be remembered by his constituents, as he contributed much to the development and progress of Barangay Kalusugan;

WHEREAS, as a token of gratitude to the loyal and humble services he had shown to his constituents and to the City as a whole, it is but appropriate for the City government to render some financial assistance to lighten the financial burden of his family as a consequence of his untimely demise.
