A RESOLUTION PROVIDING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE HONORABLE EUFROCINA DC. MAURICIO, BARANGAY KAGAWAD, BARANGAY DOÑA AURORA, DISTRICT IV, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2004 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

Mauricio, Barangay Kagawad Barangay Dofia Aurora, District IV, this City, in the amount of Forty Thousand Pesos (P40,000.00) to be charged from Grants, Subsidies and Contributions of the 2004 Annual Budget of the Office of the City Mayor or from any available funds in the City Treasury.
