RESOLUTION NO. SP-**2467**S-2004

A RESOLUTION URGING HER EXCELLENCY, PRESIDENT GLORIA MACAPAGAL-ARROYO TO ACQUIRE BY PURCHASE, THROUGH THE PAYATAS TASK FORCE APPROPRIATION LOT 76 AND LOT 81 IN LUPANG PANGAKO, PAYATAS, FROM THE RIGHTFUL OWNER AND DISPOSE THE SAME TO QUALIFIED BENEFICIARIES OF SAMAHANG TUNAY, SANSALUP AND SANGKAP ORGANIZATIONS AT A PRICE EQUIVALENT TO THE PREVAILING MINIMUM WAGE PER SQUARE METER.

WHEREAS, Lot 76 and Lot 81 located at Barangay Payatas, Quezon City, have been occupied by informal settlers for almost forty (40) years;

WHEREAS, the informal settlers occupying the said lots had grouped themselves into various organizations, namely, Samahang Tunay, Sansalup, Sangkap which are under the umbrella organization of Kalipunan ng mga Samahan ng Payatas, Inc., (KASAPI);

WHEREAS, the organization, in its desire to avail of the mass housing project of the government, have initiated contact with the Quezon City government and other national and local government agencies;

WHEREAS, there is a need to acquire and develop the subject parcels of land with the end in view of optimizing the use and productivity of land and urban resources, reducing urban dysfunctions which affect public health and safety, as well as, providing access to land housing by the underprivileged and homeless citizens.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, Her Excellency, President Gloria Macapagal-Arroyo, to acquire by purchase, through the Payatas Task Force Appropriation Lot 76 and Lot 81 in Lupang Pangako, Payatas, from the rightful owner and dispose the same to qualified beneficiaries of Samahang Tunay, Sansalup and Sangkap Organizations at a price equivalent to the prevailing minimum wage per square meter.
