RESOLUTION NO. SP- **2475**, S-2004

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT AUTHORITY TO THE BARANGAY COUNCIL OF BARANGAY MATANDANG BALARA TO UTILIZE THE OPEN SPACE LOCATED AT VILLA BEATRIZ WITH AN AREA OF TWO THOUSAND ONE HUNDRED EIGHTY-FOUR (2,184) SQUARE METERS, AS AN ALTERNATIVE SITE FOR THE CONSTRUCTION OF A BARANGAY HALL AND OTHER DEVELOPMENTAL PROJECTS WHICH COULD BE BENEFICIAL TO THE CONSTITUENCY TO BE INCORPORATED THEREIN, SUCH AS MULTI-PURPOSE, LYING-IN AND LIVELIHOOD CENTERS.

WHEREAS, the City government, through the City Planning and Development Office, cited an alternative site for the construction of a barangay hall at Barangay Matandang Balara, Third District of Quezon City;

WHEREAS, the Barangay Council of Barangay Matandang Balara is about to implement the construction of its barangay hall and has determined the site, which is covered by a Deed of Donation in favor of the Quezon City government, under Transfer Certificate of Title Numbered 50421 issued by the Register of Deeds of Quezon City and duly signed by the donor, Doña Beatriz de Zuzuarregui and the donee, representing the Quezon City government, then Quezon City Mayor Norberto S. Amoranto, for said purpose;

WHEREAS, the Barangay Council of Barangay Matandang Balara has likewise agreed to allocate budgetary provisions for a multi-purpose, lying-in, and livelihood centers in the said barangay hall, and/or the project;


WHEREAS, upon submission of the request for estimate to the City Engineering Office of Quezon City, the Barangay Council of Barangay Matandang Balara has been advised to submit an authorization to utilize the specified space for the said project;

WHEREAS, during the Barangay Council of Barangay Matandang Balara's session recently assembled, it was unanimously agreed that an authorization from the City government be secured through the Honorable City Mayor Feliciano R. Belmonte, Jr., for this purpose.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor Feliciano R. Belmonte, Jr., to grant authority to the Barangay Council of Barangay Matandang Balara to utilize the open space located at Villa Beatriz with an area of Two Thousand One Hundred Eighty-Four (2,184) square meters, as an alternative site for the construction of a barangay hall and other developmental projects which could be beneficial to the constituency to be incorporated therein, such as multi-purpose, lying-in, and livelihood centers.


