RESOLUTION NO. SP- **2480**, S-2004

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY THE QUEZON CITY GOVERNMENT WITH THE BAYAN MUNA PARTYLIST REPRESENTATIVE AND THE MIGRANTE INTERNATIONAL FOR THE COMPREHENSIVE PROGRAM FOR THE DEFENSE AND PROTECTION OF HUMAN RIGHTS OF OVERSEAS FILIPINOS.

WHEREAS, the Quezon City government, represented by the City Mayor, Hon. Feliciano R. Belmonte, Jr., has entered into a Memorandum of Agreement with Bayan Muna Partylist Representative, Hon. Crispin Beltran and the Migrante International, represented by its Secretary-General, Ms. Anna Margaritha V. Santiago;

WHEREAS, the said Memorandum of Agreement is in connection with the allocation of the sum of One Million Seven Hundred Fifty Thousand Pesos (P1,750,000.00) out of the Priority Development Assistance Fund (PDAF) of Bayan Muna Partylist Representative, Hon. Crispin Beltran, for the Comprehensive Program for the Defense and Protection of Human Rights of Overseas Filipinos of the Migrante International.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Memorandum of Agreement entered into by the Quezon City government with the Bayan Muna Partylist Representative and the Migrante International, for the Comprehensive Program for the Defense and Protection of Human Rights of Overseas Filipinos.
