A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY THE QUEZON CITY GOVERNMENT WITH THE BAYAN MUNA PARTYLIST REPRESENTATIVE AND THE ECUMENICAL INSTITUTE FOR LABOR EDUCATION AND RESOURCE CENTER PROJECT.

WHEREAS, the Quezon City government represented by the City Mayor, Hon. Feliciano R. Belmonte, Jr., has entered into a Memorandum of Agreement with Bayan Muna Partylist Representative, Hon. Crispin Beltran and the Ecumenical Institute for Labor Education and Research, Inc., represented by its Deputy Executive Director, Mr. Paul Quintos;

WHEREAS, the said Memorandum of Agreement is in connection with the allocation of the sum of Two Million Five Hundred Forty-Nine Thousand and Nineteen Pesos (P2,549,019.00) out of the Priority Development Assistance Fund (PDAF) of Bayan Muna Party List Representative, Hon. Crispin Beltran, for the Worker's Resource Center Project of the Ecumenical Institute for Labor Education and Research, Inc., for the benefit of trade unionists, labor organizers and displaced workers in Quezon City, in particular, and the worker's sector in general.
