RESOLUTION NO. SP- **2486**, S-2002

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE KAGAWAD VIRGILIO DELA CRUZ OF BARANGAY SAUYO, DISTRICT II, QUEZON CITY, IN THE AMOUNT OF TWENTY THOUSAND PESOS (P20,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2004 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, during his term, the late former Kagawad Virgilio dela Cruz ably, unselfishly and faithfully served his constituents in Barangay Sauyo;




