RESOLUTION NO. SP-2498, S-2004

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE ONE HUNDRED ELEVEN (111) FAMILIES WHO WERE VICTIMS OF THE FIRE AT SITIO LAMBAK, BARANGAY KRUS NA LIGAS, ON FEBRUARY 25, 2004.

WHEREAS, a fire occurred in Sitio Lambak, Barangay Krus Na Ligas, on February 25, 2004 victimizing One Hundred Eleven (111) families;

WHEREAS, it has been the practice of the City government to help victims of unfortunate event by way of financial assistance to support them in their hour of need.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the One Hundred Eleven (111) families who were victims of the fire at Sitio Lambak, Barangay Krus Na Ligas, District IV, on February 25, 2004, the amount to be taken from the Calamity or Emergency Fund or from any available fund of the City government as follows:

HOUSE OWNERS ----- P4,000.00
HOUSE RENTERS ----- 2,000.00

RESOLVED, FURTHER, that the Social Services Development Department shall validate and authenticate the list of fire victims categorized into family owners and family renters/sharers and submit the same to the Office of the City Mayor.






