RESOLUTION NO. SP- **2500**, S-2004

A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR. TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON MARCH 10, 2004 AT DON FABIAN, BARANGAY COMMONWEALTH, QUEZON CITY, COMPRISING OF SIX (6) FAMILY HOMEOWNERS AT TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT OF TWELVE THOUSAND PESOS (P12,000.00), TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 2004 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.




WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events."


