RESOLUTION NO. SP-**2508**, S-2004

A RESOLUTION CONFIRMING AND RATIFYING EXECUTIVE ORDER NO. 5, S-2004, OF THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., AUTHORIZING THE SOCIAL SERVICES DEVELOPMENT DEPARTMENT (SSDD) TO UTILIZE THE CALAMITY FUND OF THE CITY MAYOR FOR THE OPERATION OF EVACUATION CENTERS FOR FAMILIES AFFECTED BY FIRES AS MENTIONED SPECIFICALLY IN SAID EXECUTIVE ORDER.

WHEREAS, numerous fires occurred in Quezon City during the period from February 25 to May 5, 2004, which rendered homeless thousands of families in the City;

WHEREAS, on May 1, 2004, another fire occurred at San Roque II, Barangay Pag-asa, this City, affecting more or less One Thousand Five Hundred (1,500) families, the magnitude of the damage of which justified the classifications of San Roque II, supra, as a calamity Area;

WHEREAS, considering that the City Council was on recess and urgent action had to be taken to meet the emergency, the Honorable City Mayor promulgated said Executive Order No.5 authorizing the SSDD Head to use the City Mayor's CALAMITY Fund in operating the various Evacuation Centers set up in the Calamity Area, particularly those in San Roque II, Barangay Pag-asa;

WHEREAS, to fully legalize and validate the use of said Calamity Fund as mandated in Executive Order No.5, S-2004, it has become necessary for the City Council to confirm and ratify the said Executive Act edict;

NOW, THEREFORE,


