RESOLUTION NO. SP- **2519**, S-2004

A RESOLUTION RATIFYING THE NEGOTIATED CONTRACT ENTERED BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR. AND GRACE-LLAN CONST. AND GEN. MDSE., REPRESENTED BY ITS PRESIDENT, MS. JOSEFINA G. LLANA FOR THE CONSTRUCTION OF A RETAINING WALL AND FENCE AT FAIRVIEW ELEMENTARY SCHOOL.

WHEREAS, Fairview Elementary School has a fence located along the Tullahan River and has a length of 165 L.M. located at the top of the riprap, which has a weak foundation due to the friction of water coming from the La Mesa Dam;

WHEREAS, Grace-Llan Const. & Gen. Mdse. submitted the lowest responsive bid among the three (3) respondents who join in the bidding amounting to Fifteen Million One Hundred Seventy-Four Thousand Two Hundred Fifty-Three and 12/100 Pesos (P15,174,253.12);

WHEREAS, on September 28, 2003, the collapsed fence affected about 50 families living along the riverbank on the sidewall of the fence during heavy rains due to soil erosion;



Belmonte, Jr., and Grace-Llan Const., & Gen. Mdse., represented by its President, Ms. Josefina G. Llana for the construction of a retaining wall and fence at Fairview Elementary School.
