RESOLUTION NO. SP- **2540**, S-2004

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO GLOBE TELECOM THROUGH ITS AUTHORIZED REPRESENTATIVE MR. TITO CERVERA, SITE ACQUISITION-NCR, GLOBAL PARTNERS CONSTRUCTION AND CONSULTANCY CO., FOR THE CONSTRUCTION AND OPERATION OF CELL SITES AT SIX LOCATIONS, ALL IN QUEZON CITY.

Introduced by Councilors ANTONIO E. INTON, JR., RICARDO R. DEL ROSARIO, RESTITUTO B. MALAÑGEN, RAMON P. MEDALLA, MARY ANN L. SUSANO and DANTE M. DE GUZMAN.

WHEREAS, GLOBE TELECOM is applying for a Special Use Permit for the construction and operation of cell sites located at six locations, all in Quezon City, to wit:

1. Kabilugan - Gulod - No. 768 Quirino Hi-way, Novaliches, Quezon City.
2. Anonas - No. 76 Anonas Street, Project 2, Quezon City.
3. Hobart - No. 12 E. Cruz Street, Cruzville Subd., Barangay Kaligayahan, Quezon City.
4. AMA University - G.L. Salazar Compound, Mendez Road, Baesa, Quezon City.
5. Lung Center - Quezon Avenue, Quezon City.
6. Greenmeadows (HOA-open lot) - Wabler Street, Greenmeadows I, Quezon City.

WHEREAS, the operation of the said cell sites will serve to promote public welfare and economic development through the projected increase of employment opportunity and business opportunity in Quezon City;

WHEREAS, in accordance with the provisions of Article VII, Section 2 (h) Ordinance No. SP-918, S-2000, and its implementing rules and regulations, a Special Use Permit is required for cell sites to which the proposed projects fall under.


NOW, THEREFORE,
