A RESOLUTION INDORSING TO THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY (MMDA), RESOLUTION NO. 2003-109 OF THE SANGGUNIANG BARANGAY OF GREATER LAGRO, ENTITLED "REQUESTING THE HONORABLE OFFICE OF THE METRO MANILA DEVELOPMENT AUTHORITY TO PROVIDE MALE TOILETS (URINALS) TO BE INSTALLED AT STRATEGIC PUBLIC PLACES WITHIN THE JURISDICTION OF BARANGAY GREATER LAGRO."

WHEREAS, on August 16, 2003, the Sangguniang Barangay of Barangay Greater Lagro adopted Resolution No. 2003-109, entitled:

"A RESOLUTION REQUESTING THE HONORABLE OFFICE OF THE METRO MANILA DEVELOPMENT AUTHORITY TO PROVIDE MALE TOILETS (URINALS) TO BE INSTALLED AT STRATEGIC PUBLIC PLACES WITHIN THE JURISDICTION OF BARANGAY GREATER LAGRO."


