RESOLUTION NO. SP-2547S-2004

A RESOLUTION URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE AND ACCREDITED CONTRACTOR TO UNDERTAKE THE IMPROVEMENT AND REHABILITATION OF THE STAGE AT LAURA STREET, BARANGAY OLD BALARA, QUEZON CITY.

WHEREAS, the City Council is mandated to formulate legislative measure that would ensure safety and protection of its constituency;

WHEREAS, Laura Neighborhood Association (LANA) of Laura Street, Barangay Old Balara, Quezon City, in a letter signed by its President, Mr. Jun Cabahug, respectfully request to the Honorable City Mayor Feliciano R. Belmonte, Jr., through the City Council, to undertake the improvement and rehabilitation of their stage located at Laura Street, Barangay Old Balara, Quezon City;

WHEREAS, at present, the stage at Laura Street, Brgy. Old Balara, Quezon City, is already dilapidated and is in need of immediate improvement and renovation;

WHEREAS, said request sprung from the consultation made by the residents through their officers which happened sometime in March 2004;

WHEREAS, the rehabilitation of their stage will be of material assistance not only to the Laura Neighborhood Association but also to the residents of Barangay Old Balara as well.
