RESOLUTION NO. SP-**2550**S-2004

A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO CONSTRUCT AND INSTALL FOUR (4) ADDITIONAL STREETLIGHTS ALONG 5<sup>TH</sup> AVENUE, PARTICULARLY IN AREAS BETWEEN EDSA AND 5<sup>TH</sup> AVENUE, CUBAO, QUEZON CITY.

Belmonte, Jr., through the City Council to undertake the construction and installation of 4 additional streetlights in areas between EDSA and 5<sup>th</sup> Avenue relative to their on going crime prevention program;
